- Pick up routes should be made in timely fashion with no missed pick-ups and within the time constraints set by the company.
- Sort parcels at the Depot or at the meet point.
- Ability to read a manifest and shipping labels to sort and deliver packages in a timely manner.
- Reading and understanding of the Thomas Bros, Map system for finding the most efficient route order to make daily deliveries.
- Required to carry and use company provided radio to communicate with Dispatch staff.
- Report any unsafe or hazardous conditions to management.

- Collect and properly account for COD checks received from customers.
- Report any changes, requests, and issues relating to customers to management.
- Comply with all company policies and procedures.
- Follow established dress code.
- Responsible for timely completion of all required paperwork. Route sheets must have legible signature and have complete delivery/pick-up information.
